Polish-Czech-Slovak EuroInstitute

The Polish-Czech-Slovak EuroInstitute is a network of partner institutions that aims at fostering cooperation across borders between different actors from the Polish, Czech and Slovak parts of the cross-border region. The network is formed by:

As part of the activities of the Polish-Czech-Slovak EuroInstitute, we offer cross-border training sessions in order to provide the participants with the necessary skills to work with partners on the other side of the border. Training courses are conducted in two or three languages (Polish, Czech, Slovak), depending on the needs of the target groups.

We organise two types of training: interactive and specialised. In both types of training we use methods and tools which have been transferred from other European cross-border regions and tailored to the needs of the Polish, Czech and Slovak border area. When conducting cross-border training sessions and workshops we use, among others, the experience of Franco-German, Franco-Spanish, Austrian-Slovenian-Italian or Irish border regions.









Interactive training

Interactive training is aimed at improving soft skills, such as effective communication with your partner, working in a multinational team, creative and positive thinking in "dead-end" situations, ability to adapt to changes in a cross-border work environment, intercultural dialogue, etc. Methods used by the trainers in this type of training are informal (icebreaker, brainstorming, case studies, simulations, pair/group work, discussion, etc.) and their aim is to establish closer relations between the trainees and to create a positive atmosphere of cooperation.

Workshops are run by qualified trainers with the necessary skills and practical experience of conducting training sessions.

We offer you the following interactive training courses:

Conceptual thinking as a tool of cross-border cooperation

Aim of the training:

To acquaint participants with a creative approach to solving problems and conflicts in a multicultural work environment.

Target group:

This training is addressed to people collaborating with partners on the other side of the border, ready to reflect on their own approach towards solving problems and building a strong relationship with their neighbour.

Number of participants:

approximately 12 participants

Duration of training session:

Human resources management in an international work environment

Aim of the training:

To acquaint the participants with different approaches to human resources management by using the example of implemented or ongoing cross-border projects.

Target group:

This training is targeted at people responsible for human resources management (directors, managers, project coordinators) ready to assess their own managerial skills

Number of participants:

approximately 12 participants

Duration of training session:

from 4 up to 6 hours

Effective communication in an intercultural context

Aim of the training:

To support the development of the participants' communication skills which are necessary for effective cooperation across borders, i.e. building steady relationships with the partner, overcoming stereotypes, and ability to skilfully interpret cultural phenomena.

Target group:

This training is targeted at people undertaking collaboration with foreign partners, especially the ones on the other side of the border, who are faced with conflict situations and who strive to minimize them in order to improve the quality of cooperation.

Number of participants:

approximately 12 participants

Duration of training session:









Specialised training

Specialised training is aimed at gaining professional knowledge and skills in well-defined areas, such as, among others: law and administration, education, crisis management, environmental protection, etc. This type of training seeks not only to present the given topic with a special focus on its cross-border specificity and to exchange experiences, but also to compare different administrative systems, management methods, range of skills typical of each country, and good practices used in the neighbouring country. Moreover, these training sessions promote cross-border cooperation in specific fields of expertise by connecting institutions that seek a partner on the other side of the border. They are conducted in the form of a lecture which, however, offers the participants the opportunity to speak. Training sessions are run by experts in the given subject matter who have not only the necessary skills but also many years of practical experience.

We would like to offer you the following specialised training courses:

Vocabulary of cross-border cooperation, available in Polish, Czech and Slovak

Aim of the training:

To improve the participants' language skills in the field of cross-border cooperation. Our approach is based on linguistic and cultural similarities and differences between each of the involved countries.

Target group:

This training is addressed to people who have contact with their neighbour's language in their professional life, and who wish to explore its specificity and subtleties in order to communicate more effectively in a cross-border work environment.

Number of participants:

approximately 18 participants

Duration of training session:

Good practices in cross-border actions

Aim of the training:

To broaden the participants' knowledge on how to implement projects based on the transfer of good practices from other border regions. This is perceived as a means to build capacity for cross-border cooperation, through an exchange of information and experiences.

Target group:

This training is targeted at people involved in cross-border cooperation, having an impact on its development and plans of the future courses of action, people who are open to innovation and ready to take on new challenges.

Number of participants:

approximately 18 participants

Duration of training session:

from 4 up to 6 hours

Fundraising for projects carried out with foreign partners, illustrated by the example of cooperation with young people

Aim of the training:

To acquaint the participants with various possibilities of raising funds for cross-border initiatives from European programmes, with a special focus on actions aimed at establishing relations with young people and investing in the potential of the young generation (informal education) – case studies.

Target group:

This training is targeted at people seeking opportunities to finance cross-border projects, especially those which initiate and support actions pitched at young people and have a direct or indirect impact on the education process of young people.

Number of participants:

approximately 18 participants
